200 Club

The Oldland Mill Trust "200 Club" will be running for the Eleventh year, under the Gambling Act of 2005, with a licence from Mid Sussex District Council. For 2022– 2023 we sold 176 tickets and we would love to increase that figure this year.

For an annual contribution of £12, we will return 50% of the monthly income in prizes. This will be paid in three prizes of 50%, 30% & 20% until we have 200 members. For every 25 additional members, there will be one additional monthly prize added of £20. At 200 members, monthly prizes of £50, £30 & £20 will be paid, and pro-rata below this level. For members joining after the first draw, the annual contribution will reduce by £1 for each month they have not participated in the draw.

PAYMENT FOR TICKETS MAY BE MADE BY CHAPS BANK TRANSFER, CASH OR CHEQUE PAYABLE TO OLDLAND MILL TRUST. IF PAYMENT IS MADE BY CHEQUE THE MEMBER HEREBY AGREES THAT PAYMENT OF ANY PRIZES MAY BE MADE BY CHAPS BANK TRANSFER DIRECT INTO THE BANK ACCOUNT ON WHICH THE CHEQUE IS DRAWN.

The first draw will be on Thursday 20th July 2023 and on the third Thursday each month until June 2024 at Oldland Windmill in the presence of the Volunteers.
